Writing Requirement:

- Students receiving a “B” or better in ENGL 102, 108, or 109H must complete 1 POL or LAW writing emphasis course with at least a “B”.
- Students receiving a “C” or worse in ENGL 102, 108, or 109H must complete 2 POL or LAW writing emphasis courses with at least a “B” in one, and at least a “C” in the other.
- Taking a writing emphasis course pass/fail will not satisfy this requirement.
- Courses marked with an * are the writing emphasis courses approved for the law major.

Major Upper Division: A minimum of 18 units of upper division major coursework is required.

Residency Requirement: A minimum of 18 units of the Law coursework must be taken at the University of Arizona.

Fee: All students with junior or senior standing and a declared major in Law will be charged a \$900/semester differential tuition until they graduate or start law school.
