# **UArizona Student Spotlight: Pam Kline**

In August, the University of Arizona James E. Rogers College of Law will award the first three Legal Paraprofessional (LP) Graduate Certificates. Pamela Kline is one of the Master of Legal Studies (MLS) students to achieve this new milestone.

Pam is a Board-Certified Clinical Specialist in Geriatric Physical Therapy and has her clinical doctorate in physical therapy. She started the MLS program in 2018 interested in continuing her professional development in the healthcare field. Always passionate about history and law, Pam states, "The online MLS program fit my interests, goals and busy schedule."

Pam learned of the LP opportunity during her final year in the program and decided to extend her plan of study to take the required LP courses to pursue a future license to practice Administrative Law.

With the help of **Dr. Linus Kafka**, Assistant Director for the BA in Law and MLS programs, Pam secured an internship with the Industrial Commission of Arizona Workers' Compensation Division. Although admittedly not the Administrative Law area she had envisioned, Pam was pleasantly surprised by the overlap between her medical background and MLS education as it applied to this new area of law.

"I would advise future LP students to be open to any internship opportunities and

look for ways in which their unique skill sets can contribute to the worksite while they grow in their new legal skills. Also, remember that every interaction is an opportunity to expand your professional network."

In addition to earning the LP Certificate, Pam also completed the required course work to earn a **Health Law Certificate**.

Pam's advice to anyone considering furthering their education is, "Start and keep moving forward in your program of study. You may have to pause (as I did) for life issues, but one class at a time, you will complete your goal. I look forward to discovering the opportunities my U of A journey will create in my future."

## **LP Ranks Continue to Grow**

Four more LPs earned their license to practice at the recent Board of Nonlawyer Legal Service Providers meeting on July 18, 2022.

Alejandra Gerardo, Tara Hughes and Rhonda Chatman joined the LPs who are currently licensed to practice family law, bringing the total number of licenses for the family law practice area to twenty.

Julie Rodriguez was licensed to practice civil law, joining Chelsea Woodworth as the two LPs possessing a license in the civil area of practice. Notably, Woodworth is the only LP to date licensed to practice both civil and family law.

Based on information reported during the meeting, there are an additional 11 LPs who are eligible for licensure having passed both required exams. This group may be able to receive licenses as soon as the next meeting scheduled for Sep. 26.

Also of note is the addition of two LPs to the Board of Nonlawyer Legal Service Providers. Their input and guidance will be important for all future developments in the LP profession.


