

# Legal Paraprofessional Scholarship Opportunities

### Student scholarship deadline to apply is Wed., Nov. 30

With **Marshall Foundation** support, the University of Arizona James E. Rogers College of Law is proud to announce two scholarship opportunities to support Legal Paraprofessionals (LPs), which will be awarded on a first-come, first-serve basis for up to 40 applicants.

The **Marshall Foundation Legal Paraprofessional Scholarship** will support students who wish to obtain the necessary education to become an LP. Selected students will receive a one-time award applied to the costs of attendance associated with the University of Arizona **BA in Law**, the **Master of Legal Studies** (MLS) program or the accelerated MLS program for qualified BA in Law students.

#### University of Arizona Newsletter

Application materials for the Marshall LP Scholarship must be submitted by 5:00 p.m. on November 30, 2022. Scholarships will be distributed in Spring of 2023.

Candidates who have completed coursework are eligible to apply for the **Marshall Foundation LP Graduation Award**, which supports the licensure process by reimbursing selected candidates for the costs associated with state testing and license application fees. The Marshall LP Graduation Award applications will be considered on a rolling basis.
