Under my leadership the University of Arizona College of Law has been recognized as an innovator in legal education and the legal profession. This leadership is reflected in my Winter 2017 *National Jurist* ranking as the 8th most influential person in legal education – though, needless to say, institutional innovation is very much a team sport. Major innovations include the addition of the GRE as an option for JD admissions (an innovation now followed by Harvard, Georgetown, Northwestern and more than 30 other law schools), the creation of the first BA in Law in the US (with more than 1200 students after the first 4 years), the globalization of the JD program (with more than 20% of JD students coming from outside the US), originating the idea of the Arizona “3L February Bar” option, the reduction in nominal and actual JD tuition to respond to market demand and embrace our public roots (UA COL ranks 7th in value), expansion of clinical and experiential learning opportunities (UA COL now ranks 6th in the US in experiential learning), significantly increasing diversity of the student body, faculty and staff, professionalization of the Arizona Law legal writing program (now US News top 25), the creation of unique global dual degree partnerships, the development of new programs in law and technology (TechLaw@ArizonaLaw), intellectual property, US and international business law, advocacy, legal writing, civil justice, access to legal services (Innovation for Justice), mining and natural resources, regulatory science, empirical and experimental legal and policy studies (QuantLaw), participatory democracy, leadership, and other areas, including innovative partnerships throughout UofA Colleges and Departments.

My job for the past six years has been in academic administration. For most of my academic career I have been a law school teacher and legal scholar, though for many years I also carried administrative responsibilities at both Arizona and Emory (my prior professional home). I began publishing professional articles as a law student at Chicago, and since that time I have written more than 70 articles and essays on a wide range of environmental, criminal justice and legal theory topics. I am a co-editor on several widely used casebooks on criminal procedure and sentencing, and co-founded the *Federal Sentencing Reporter*, the leading journal on sentencing law and policy and a joint project of the Vera Institute of Justice and the University of California Press. For many years I have been ranked in the top 20 most cited criminal procedure scholars in the United States. I currently serves as a series editor for *Summits* — books published by the University of Chicago Press and focused on the intersection of environmental science, law and policy.
